重要提示 Important Notes To Client

- 1. 如股票登記持有人為中央結算有限公司,客戶須提供提貨收據或其他檔案,証明其擁有權。此外,客戶亦可先將股票轉入其名下,才將股票存入本公司。否則,本公司將不接受該股票存入。
