我司作為香港證券及期貨事務監察委員會("證監會")的持牌機構,須遵守《證券及期貨條例》及《證券及期貨事務監察委員會持牌人或註冊人操守準則》("《操守準則》")的規定及其他規定。

As entities licensed by the Hong Kong Securities and Futures Commission ("SFC"), amongst other matters, CZHF are required to comply with the provisions of SFO and the requirements of the Code of Conduct for Persons Licensed by or Registered with the Securities and Futures Commission ("the Code").

專業投資者身份 Professional Investor Status

 be able to make unsolicited calls to you for the purpose of marketing or recommending securities and other investment products; and

 in relation to any offer of securities, not be required to provide you with materials or information in the form prescribed by section 175 of the SFO.

If services are to be provided to the client in relation to derivative products, we will provide the client upon request with product specifications and any prospectus or other offering document covering such products and a full explanation of margin procedures and the circumstances under which a client's positions may be closed without the client's consent.

No other provision of this agreement or any other document we may ask you to sign and no statement we may ask you to make derogates from this clause.

- (i) 向閣下提供有關我司的資訊,或者告知閣下有關代表我司行事的我司員工及其他人的身份及資格; inform you about the licensed or registered person and the identity and status of our employees and others acting on our behalf;
- (ii) 為閣下執行某個交易後立即向貴司確認該交易的基本特點;及 confirm promptly with you the essential features of a transaction after effecting a transaction for you; and
- (iii) 向閣下提供關於納斯達克一美國證券交易所試驗計劃的資料文件 provide you with documentation on the Nasdaq-Amex Pilot Program.

作為個人專業投資者的權利 Rights as an Individual Professional Investor
